"Decade-Old and Innovative New AMD Passive Treatment Systems and Reclamation Methods"

Return - Sunday, June 6 at 5:00 pm

<u>Description</u>: Join us for a two-day field tour of sites illustrating various approaches to restore land and water resources impacted by abandoned coal mining activities in Pennsylvania. Described will be "lessons-learned", upgrades to older systems, and long-term maintenance requirements. The first day will highlight the 13-year old passive system treating iron- and aluminum-bearing acidic drainage and a demonstration of the Appalachian Regional Reforestation Initiative. Resource recovery of manganese-bearing solids will also be demonstrated at a passive system in the Slippery Rock Creek Watershed. The evening of June 5 will be spent enjoying the beautiful rustic town of St. Mary's including a tour of the Straub Brewery, which boasts of an "Eternal Tap" for sampling. The second day will include the Dents Run Watershed in the Pennsylvania Wilds to visit both active and passive systems (We may also see an elk herd!!) with a guided tour by the PA Bureau of Abandoned Mine Reclamation. This two-day tour is hosted by the PA Department of Environmental Protection, PA Department of Conservation and Natural Resources, Bennetts Branch Watershed Association, Slippery Rock Watershed Coalition, Stream Restoration Inc., and BioMost, Inc.

Update on The Slippery Rock Creek Watershed Conservation Plan

The Slippery Rock Creek Watershed Conservation Plan (SRC WCP) is underway! The Plan provides critical data for stakeholders and enables sustainability and viability of the watershed. The Mission of SRC WCP is to "provide the general public, municipalities, watershed community, and government agencies with a concise, easily read and used repository of the natural, historical, cultural and recreational resources while emphasizing opportunities for stewardship and economic growth within the Slippery Rock Creek Watershed." Along with the Advisory Council, Community Outreach has been essential in identifying watershed-specific problems, issues and concerns. The online Citizen Survey is open to the residents of the Slippery Rock Creek Watershed. Please complete the survey at http://www.surveymonkey.com/s/SRCWCPcitizen and let your voice be heard! This is your watershed!

We are working diligently to have a draft plan completed by the end of 2010 and public meetings in early 2011. The SRC WCP Advisory Council has been a vital source in this early phase of the plan. Right now, we are collecting data and writing each individual section of the plan. These include: Project Area Characteristics, Land Resources, Water Resources, Biological Resources, Cultural Resources, and Management Options. Geographic Information Systems (GIS) mapping will be a major part of the plan and will provide an overall picture of the watershed describing various sorts of information (i.e. population, land use, wetlands, etc).

We are excited about the SRC WCP and hope that it can be utilized in the future by watershed groups and other stake-holders to help ensure the Slippery Rock Creek Watershed remains a unique and amazing place in Pennsylvania. 

All About Rainbows

You've probably heard the saying "April showers bring May flowers." But the rain showers we'll see the next couple months may also bring some rainbows! Have you ever wondered what makes a rainbow? Ordinary white light, like that from the sun, is made up of many different colors. Each of these colors has a different wavelength. Normally, when we see light from the sun, it appears colorless. However, Isaac Newton discovered in 1666 that when he passed regular sunlight through a prism (basically, a triangular piece of glass), the prism would split the light up into a band of colors. The band of colors is called the spectrum, and it appears in the order of red, orange, yellow, green, blue, indigo, and violet. When it rains, the air is filled with raindrops. These raindrops act like a prism. If sunlight passes through the raindrops at the proper angle it is split into its spectrum, which is made up of the colors of the rainbow.

TRY IT: You can make your own rainbow at home by filling a plastic box with water and placing it near a sunny window. If the wall next to the window isn't white, place a piece of white paper next to the window. Next, place a mirror inside the box of water facing the window. The mirror needs to be tilted towards the sunlight. The wedge of water in the front of the mirror acts like a prism and the mirror reflects an image of a rainbow right there on your wall! H.O.P.E. (Highlighting Other Partnership Efforts)

In honor of Earth Day, a small group gathered in a volunteer effort to work with **PA Clean Ways** to clean up a trashfilled area of Canton Township. Several participants of the **Chartiers Creek Watershed Association** and residents of the **Buffalo Creek Watershed** were on hand to pitch in, and there was a lot of garbage that had been pitched, unfortunately, over hillsides and onto the creek bed!

Led by **Laurie Popeck**, who serves as the chapter coordinator of PA Clean Ways in Washington County, the enthusiastic volunteers certainly made a difference in the area they cleaned up, though many were overwhelmed at the amount of trash present. Their amazing tally in this their second of 4 spring cleanups included more than 430 (!!!!) tires, 35 bags of trash, two televisions, two toilets, two tables, two box springs, and an assortment of building material.



Ronald "Rocky" Harton, township roadmaster, was amazed by the number of tires collected. "It is unbelievable," Harton said. "I think someone is getting paid to dispose of tires and instead, just dumps them on the side of the road." He noted that it cost the township \$400 last year to dispose of the tires found along the road.

The Earth Day Network Action Center suggested five things on their web site which any ordinary person could do for Earth Day to make a difference in improving the environment around them. Laurie and the other volunteers "took action" by following the "action point" of "I will organize a clean-up in my community and pick up litter whenever I see it."
