SRWC at the PA AMR Conference

The 2011 PA Statewide Conference on Abandoned Mine Reclamation (a.k.a. AMR Conference) took place August 4 through August 6 at the Best Western Genetti Inn & Suites in Hazelton, PA. "Working Together for Innovation and Success" was the motto this year, which marked the 13th annual PA AMR Conference and also coincided with the 15th anniversary of EPCAMR. The Eastern PA Coalition for Abandoned Mine Reclamation (EPCAMR) served as the host of this year's conference, which was attended by 2 participants of the SRWC, **Cliff Denholm** and **Shaun Busler**.

Shaun and Cliff participated in a fieldtrip Thursday, August 4th, which was a tour of Abandoned Mine Lands and Mine Drainage sites in the Tamaqua / Hazleton area led by a team of local watershed groups. The tour included AMD sites and treatment systems in the Catawissa Creek, Nescopeck Creek, and Schuylkill River Watershed. Thursday evening, Cliff and Shaun enjoyed a special dinner/fundraiser which was held to commemorate EPCAMR's 15th Anniversary. To aid in the celebration, 150 "fish-shaped" magnets were presented at the special dinner. A special "thank you" to ceramic artist Bob Isenberg of the Pottery Dome for creating the magnets and to Clean Creek Products for generously donating these mementos.

Friday, August 5th, was a day filled with presentations for Cliff and Shaun. Over 20 presentations were offered to attendees and divided into two tracks to run simultaneously on Friday and Saturday. A half-day workshop on Grant Writing and Seeking Community Foundations for Support also ran concurrently with the Conference. The presentations included topics such as the Marcellus "Gas Rush" and ties to AMD / Mine Pool Use, Successful TMDL Implementation, PA Coal Mining History, Watershed Implementation Projects utilizing Landscape Architecture, Developing Qualified Hydrologic Unit Plans, Mine Pool Mapping, Showcases of Successes in AMD Treatment, and Partnerships between Watershed Groups and Industry.

The PA Department of Environmental Protection's Secretary, **Michael Krancer**, spoke at the conference on Friday, and Shaun was glad to personally meet him. Other speakers included Director of the Federal Office of Surface Mining Reclamation & Enforcement, **Joe Pizarchik**, and Renew Growing Greener's Executive Director, **Andrew Heath**.

Friday evening, August 5th, Shaun and Cliff attended a dinner where the Mayfly Award was presented to this year's winner: **Dave Hess**, former Secretary of the DEP. The Mayfly Award is presented to those individuals who exhibit long-term efforts in addressing mine drainage remediation projects in PA and has contributed greatly towards cleaning up PA's environment from abandoned mine drainage impacts. Congratulations to Dave!

Cliff and Shaun led a hands-on training workshop on Saturday on the use of **Datashed**, a web site developed through a partnership effort to provide an open and easy-to-use repository of information related to passive treatment systems and abandoned mine land projects. At the workshop, Datashed 2.0 was debuted, which is the latest upgrade to the website. Although still in beta testing, Datashed 2.0 includes all of the features of the original site plus many additional capabilities. Anyone with access to an internet connection can view the valuable information that is regularly being updated as new data are collected. While the amount of documents and data available will vary from project to project, information such as treatment technologies, water monitoring data, site schematics, photos, Operation and Maintenance Plans, design and/or "As-built" drawings, directions to the project, aerial photos, various reports, etc. can be viewed on the website. During the workshop, Shaun and Cliff covered how to use Datashed to view project related information, create new projects, create new water sampling points, edit existing information, enter/upload data, upload project-related files, and more.

Shaun and Cliff were also encouraged by the interest in the products they brought to sell from Clean Creek Products (www.cleancreek.org). The jewelry they brought from the "green store" sold well; check out the full line of goods online if you haven't done so already! Remember everything is made in part by the metals recovered in treatment of abandoned coal mine drainage, with most of the proceeds going to local watershed groups to support their continued cleanup efforts!

Endangered Species Word Search

There are more than 1,970 endangered species of wildlife (including plants!) in the United States. The term "endangered" means the animal or plant species is in danger of becoming extinct because it is either few in numbers or is threatened by changes to its habitat or predation. Other species are called "threatened", which means the species are vulnerable to endangerment in the near future. The American bald eagle is one of the best-known animal species which used to be on the endangered species list. In the early 1960s there were only about 450 nesting pairs of bald eagles in the lower 48 states. Bald eagles were officially declared an endangered species in 1967 in all areas of the United States south of the 40th parallel. The Endangered Species Act was signed into law in 1973 by President Richard Nixon. On July 4, 1976, the US Fish and Wildlife Service officially listed the bald eagle as a national endangered species. With the help and protection of these laws, the number of pairs of nesting American bald eagles increased to over 4500 in the 1990s. Today there are an estimated 9789 pairs of nesting bald eagles, and the bald eagle was removed from the endangered species list in June 2007. It is still protected under the Migratory Bird Treaty Act and the Bald and Golden Eagle Protection Act. 15 of Pennsylvania's endangered species are listed below, and hidden in the word search. Volunteers

The Slippery Rock Watershed Coalition is seeking volunteers who are willing to "Adopt A Passive Treatment System" by assisting with water monitoring and site inspections. The volunteers will be asked to go to one or more passive systems, preferably on a monthly basis, to inspect the systems and conduct basic water monitoring using test kits and then enter the information into "Datashed", an internet-based database. Water quality test kits as well as training on conducting the inspections, using the test kits, and entering the collected data on-line, will be provided.
