Hunting Opportunities Abound in the Watershed

As fall approaches, many venture outside to hunt. The Slippery Rock Creek Watershed is blessed with many different hunting opportunities. For those without permission to hunt on private land, thousands of acres of public land are available. Some of these opportunities are highlighted below:

State Game Lands: As previously noted, five State Game Lands (**SGL**) are located within the watershed: *SGL #95* in Butler County, *SGL #130* in Mercer and Venango Counties, *SGL #151* and SGL *#284* in Mercer and Lawrence Counties and *SGL #216* in Lawrence County. The 9,383-acre State Game Lands #95, Butler County's largest preserve with over 6,000 acres in the watershed, is noted for bear, deer, turkey, small game and waterfowl.

State Parks: Hunting and trapping are permitted in designated areas and during established seasons in both McConnells Mill and Moraine State Parks. The training of dogs is also permitted in the hunting areas of both parks from the day after Labor Day through March 31 of each year. The hunting of woodchucks or ground-hogs is prohibited at both parks. Common game species at *McConnells Mill State Park* include grouse, deer, turkey, rabbit and squirrel. Approximately 13,600 acres is available for hunting and trapping at *Moraine State Park*, where popular game species include waterfowl, deer, turkey, grouse, bear, rabbit, pheasant and squirrel.

Conservation Lands: Hunting and trapping is permitted on Western Pennsylvania Conservancy (WPC) properties in accordance with Pennsylvania Game Laws. Two WPC properties are located in the Slippery Rock Creek Watershed: the 33-acre *Miller Esker Natural Area* and the 115-acre *Wolf Creek Narrows Natural Area*. Both tracts are located near Slippery Rock, PA.

New Sludge Pond Constructed at SR101A

As part of the Slippery Rock Passive Treatment Rehab & Maintenance grant, the SRWC is rehabbing several passive treatment systems in the headwaters of Slippery Rock Creek on located on State Gamelands #95. One of those sites is SR101A. The SR101A passive system was constructed in 1998 and is now 23 years old! This system was one of the first constructed in the watershed and has continuously been treating water since it was constructed with little maintenance. The ALD currently is functioning well, but additional limestone will likely be needed in the next five years. The settling pond and wetlands are also full of iron sludge and organic debris to the point they are beginning to reduce treatment efficiency. In places, the AMD is flowing over the berm of



wetland 1, thereby bypassing a portion of the treatment, potentially damaging the berm, and creating a sloped wetland on the berm. Last month, a new sludge pond was built by **Ryan and Cory Mahony of Bio-Most, Inc.** This pond was filled with the iron sludge and organic debris from the settling pond and wetlands in the passive treatment system. Cleaning these ponds and wetlands will increase the sludge capacity and effectiveness of the treatment system. Thanks to Ryan and Cory for getting a little orange!
